13TH DECEMBER, 2001**

THE LEADER OF THE HOUSE AND THE MINISTER OF EXTERNAL AFFAIRS (SHRI JASWANT SINGH): Mr. Chairman, Sir,...

SHRI JASWANT SINGH: Sir, it is a legitimate requirement of copies in both Hindi and English. In the meantime, with your permission, Sir, on behalf of my senior colleague, the Home Minister, I would like to make the following statement in connection with the terrorist attack on Parliament House on 13th December, 2001.

The ghastly attack on Parliament House on 13th December, 2001 has shocked the entire nation. The terrorist assault on the very bastion of our democracy was clearly aimed at wiping out the country's top political leadership.

It is a tribute to our security personnel that they rose to the occasion and succeeded in averting what could have been a national catastrophe. In doing so, they made the supreme sacrifice for which the country would always remain indebted to them. It is now evident that the
