the post of Joint Director General onward, ignoring the fact that the qualifications, duties and responsibilities of the higher posts are mainly oriented to discipline of archaeology;

- (b) whether it is also a fact that due to the above fact that officers of Archaeological Survey of India have no chance to become the Director General after the retirement of the present incumbent in the middle of 1990; and
- (c) whether Government propose to re-examine the anomalies in the recruitment rules of Gorup 'A' Offices and restore status quo ante; and if so, by when?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI):

(a) The recruitment rules of Group 'A' post were amended in 1982 keeping in view all the relevant considerations and by following the prescribed procedure.

- (b), This is only incidental and not due to any procedural defect in the Recruitment Rules for the post of Director General.
- (c) At present there is no such proposal.

Harassment of Indians in Bhutan

- (a) whether Government are aware of the reports that a sizeable number of Indian labourers have been forced to leave Phuntsolong and other areas of Bhutan:
- (b) whether Government are also aware that Indians occupying senior positions in both official and commercial establishments are preparing to leave Bhutan because of harassment; and
- (c) if so, what steps Government are taking to protect the interests of Indians there and to meet the changing situation?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) Government have seen reports to this effect,

(b) No. Sir.

The Government are aware only about expulsion of non-nationals in Bhutan without valid documents. Most of them were nationals of countries other than India.

(c) In genuine cases where the interests of Indian nationals are affected. these matters are taken up with the Royal Government of Bhutan for resolving problems amicably.

Sale and Purchase of Reserved Tickets by Unauthorised Persons Travel Agents at New Delhi Station

- (d) if so, what action has been taken by Government in this regard?

THE MINISTER OF STATE OF OFTHE MINISTRY RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) and (c) Some such cases have come to

- (b and (d) Some of the important measures taken to curb malpractices in reservations by touts unauthorised persons are as under;
- (i) A close surveillance is being maintained at New Delhi reservation office to detect and apprehend touts.

Surprise raids are also conducted at the premises of unauthorised travel agents. During 1988-89, 91 touts/unauthorised agents were apprehended and handed over to Police for prosecution.

- (ii) During rush periods, reservation requisition slips are scrutinised with a view to detect spurious reservations. Door-to-door verrification of the spurious requisition slips is done and the reservations are cancelled where these are found fictitous.
- (iii) Frequent warnings to intending passengers against unauthorised purchase sale of tickets are issued through notices and announcements over Public Address System.
