- (c) if so, what steps Government propose to take to investigate the matter thoroughly and to take steps to check effectively the shady operati6ns of unscrupulous private couriers which were reported to be responsible for most Of the air disasters which occurred in different parts of the country recently?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL): (a) Yes, Sir.

- (b) Yes. However, the explosion occurred on 11th April, 1989.
- (c) West Bengal Police have registered a ease in this connection and have arrested two employees of the courier.

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI-MADHAVRAO SCINDIA); (a) All essential medicines required are available at Railway Hospital, Lallaguda, though these may not be Under specific brand nauies.

- (b) The work of increasing the bed strength of this hospital has been sanctioned and included in the Works Programme of 1989-90.
- (c) Some times special drugs, drugs with short shelf-life or drugs which run short due to sudden spurt in the incidence of a particular disease etc. have to be procured locally.
