## Vacant Posts in Groups A and B in Kendriya Vidyalaya Sangathan

785. SHRI ASHOK NATH VERMA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that a large number of vacancies of Group 'B' and Group 'A' Officers remained unfilled in the Regional Offices of the KVS located throughout the country for a long period;
- (b) if so, what are the categories of vacancies Region-wise and post-wise;
- (c) what are the reasons for delay in filling up these vacancies; and
- (d) by when these vacant posts are likely to be filled up?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) and (b) A statement giving the details of vacant Group 'A' and 'B' posts in various Regional Offices is annexed. [See Appendix CL, Annexure No. 43].

(c) and (d) Recruitment action is a continuous process and action has been initiated to fill up the posts as per rule.

## Schools providing Vocational Education in Orissa

786. SHRI BAIKUNTHA NATH SAHU: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) Whether Government have taken steps to vocationalise Education Programme;
- (b) whether Vocational Education has been introduced by the Central Government in some schools in different States; and
- (c) if so, what is the number of schools in Orissa where Vocational

Education has been introduced under the Central Scheme so far and also proposed to be introduced during the remaining period of the Seventh Plan?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) A Centrally Sponsored Scheme of Vocationalisation of Secondary Education has been started in February 1988 to promote vocational courses at +2 stage. Under this scheme financial assistance, is available to States/UTs for starting vocational courses.

- (b) Yes, Sir.
- (c) In Orissa sanction has so far been given for starting 724 vocational courses in 181 schools. The proposal for 1989-90 has yet to be received from the State Government of Orissa.

## Gujarati Fishermen in Pakistani Jails

- 717. SHRI MIRZA IRSHADBAIG: Will the Minister of EXTERNAL AFFAIRS be pleased to refer to the answer to Unstarred Question 3302 given in the Rajya Sabha on the 29th March, 1989 and state:
- (a) whether it is fact that a number of Gujarati fishermen and boats were kidnapped by Pakistani authorities from the sea of Gujarat Coast and Jakho Harbour and are still in their custody:
- (b) if so, what are the details thereof;
- (c) whether Government have received any representations in this regard; and
- (d) if so, what measures have been taken by Government in the matter?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P V NARASIMHA RAO): (a) and (b) Four boats with 33 fishermen were captured on 26.10.88

and two boats with 12 Gujarati fishermen were captured on 3.4.1989.

- (e) Yes, Sir.
- (d) The Government has been requesting the Pakistan Government to release and repatriate the fishermen and the boats.

## Relief Supplies for Earthquake Victims in U.S.S.R.

788 SHRI K. V. THANGKA-BALU. Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government have extended cooperation in sending relief supplies for the victims of earthquake in the U.S.S.R.; and
- (b) if so, what. are the details thereof?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) Yes, Sir.

(b) Five IL-76 planeloads of relief supplies totalling over 150 were airlifted between 10th to 28th December, 1988. The items included supplies from the various agencies of the Government the Red Cross, and donations by private industry. mix of the relief supplies was decided in consultation with Soviet authorities taking into account their priorities. Indian relief supplies includwoollens. arctic ed blankets and beds, tents, stretchers and hospital various categories of medical surgical equipment and drugs. In ad-Minister's Armenia dition, "Prime Earthquake Relief Fund" has constituted to channelise cash contributions from private citizens and institutions all over India State Governments and the administrators of Union Territories were requested to facilitate the receipt of cotributions.
