Show cause notice issued by Collector Central excise Patna on M|s. I.T.C. Limited

1085. SHRI VIRENDRA VERMA: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that the Collector Central Excise, Patna, vide show cause notice dated 3rd July, 1987 reopened some of the issues in respect of despatches from the factory of M/s ITC Limited at Monghyr on account of short levy of Central Excise Duty amounting to Rs. 43.48 crore besides penalties;

- (b) whether similar notices dated 25th September, 1987, 21st October, 1987, 27th January, 1988 and 27th July, 1988 were served by Collector Central Excise, Bangalore, Calcutta, Bombay, Meerut respectively alleging short levy of Central Excise Duty in respect of despatched from ITC Limited factories at Bangalore, Kiderpore, Parel and Saharanpur;
- (c) whether it is also a fact that such show cause notices were served on M|s. I.T.C. Limited after obtaining the opinion of the Ministry of Law in the matter; and
- (d) if so, what are the details of the recoveries made so far, stating the reasons for non-recovery of the amount in full?

THE MINISTER OF STATE IN THE DEPARTMENT OF REVENUE IN THE MINISTRY OF FINANCE (SHRI AJIT PANJA): (a) Yes, Sir. However in the show cause notice dated 3-7-1987, the amount involved is Rs. 39.82 crores only. There is another show cause notice dated 2-7-1987 on the same issue involving evasion to the tune of Rs. 4.06 crores.

(b) Similar show cause notices, alleging evasion of Central Excise duty in respect of other factories of M/s I.T.C.

Limited, have also been issued, the details of which are as under:-

- (c) The above show cause notices have been issued for under valuation. The computation of differential duty on the money value of the additional consideration received by M/s, I.T.C. Ltd. on their sales, has been based on the opinion of the Law Ministry.
- (d) All these cases are pending adjudication before the Director—General of Inspection (Customs and Central Excise), New Delhi, and the question of recovery of any amount will arise only after these cases are adjudicated resulting in confirmation of the demands.

Ban Sagar Project
