Mismanagement of Traffic in Delhi

- (a) whether Government's attention has been drawn to the report published in the 'Statesman' dated the 22nd March, 1989 regarding mismanagement of Traffic in Delhi and, if so, what corrective steps are proposed to be taken;
- (b) whether Government propose to set up Consultative Advisory Committees in each locality of Delhi with participation of interested public groups thereon;
- (c) whether Government propose to select at least 200 Honorary Traffic Wardens in the city of Delhi who may be authorised to report to Police with brief details on vehicles who are breaking the traffic laws and make its obligatory for the Police to take action on such report within 10 days; and
- (d) whether Government are aware that number-wise and alphabetically name, wise lists of vehicles and owners and drivers have not been compiled and updated and made available to every Police Station in Delhi so far, which explains failure to apprehend offenders with speed and precision?

- (b) A number of consultative advisory committee, are already functioning in Delhi.
- (c) The Traffic Police has 303 Honorary traffic wardens who are authorised to report details of vehicles breaking traffic laws. The offending vehicles are then issued notices from the office of the DCP, Traffic.
- (d) There is a control room functioning in the Directorate of Transport (Telephone No. 230782) on a 24 hours basis from where ownership details of vehicles can be obtained, particularly outside office hours.

Quantity of DL 2 Aminobutanol required for production of 1 Kg. of Ethambutol

- (a) whether it is a fact that for the production of one Kg. of Ethambutol, only 1.89 Kgs. of an intermediate known as DL-2 Aminobutanol is required;
- (b) whether it is a fact that his Ministry allowed higher drawback based on light consumption of DL-2 Aminobutanol;
- (c) whether it is also a fact that there i_s loss of foreign exchange o_n the export of Ethambutol; and
- (d) if so, what steps are being proposed to investigate the entire seandal and by when investigation will be completed.

consumption of DL-2 Aminobutanol ranging between 2.00 Kgs. and 2.37 Kgs. has been permitted against export of 1.00 Kg. of Ethambutol. Such norm of consumption was allowed after due verification of the records of production of different firms. The consumption norms have been gradually brought down by producing firms in 1988 by introduction of new technology and equipment. The present consumption norm as fixed by D.G.T.D. and incorporated in Import-Export Policy 1988-91 prescribes a norm of 2.20 Kgs. of DL-2 Aminobutanol 1 Kg. production of Ethambutol Therefore, the norms adopted for duty drawback purposes have been realistic.

- (c) The amount of foreign exchange spent by various exporters on importing different inputs and the foreign exchange earned for export of this product has not been studied. (Drawback is not dependent on these factors, being only a compensation for the duties of Customs and Central Excise suffered on the inputs used in the product exported).
- (d) Does not arise in view of replies to parts (a), (b) and (c) above.

Investigation of the cases of over invoicing for imports of intermediates of Rifampicin and Ethambutol

Minerals and Metals Trading Corporation's assistance to Andhra Pradesh in the production of Minerals

- (a) whether the Minerals and Metals Trading Corporation of India has any plans to assist the Andhra Pradesh Mining/Mineral Corporation in the production and sale of barytes, granite, bauxite and other minerals:

- (c) whether any negotiations are going on with the Andhra Pradesh Government in this regard; and
 - (d) if so, what is the outcome thereof?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI P. R. DAS MUNSHI): (a) and (b) MMTC has entered into an agreement with Andhra Pradesh mineral Development Corporation (APMDC) to assist them in the sale of barytes. MMTC's assistance liquidation of APMDC's has included stocks of barytes by exporting them, and grant of loans to the tune of Rs. 231 lakhs. MMTC has no plan at present to assist APMDC in sale of other minerals.
