THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC AFFA-IRS IN THE MINISTRY OF FINANCE (SHRI EDUARDO FALEIRO): (a) and (b) The General Insuarance Corporation of India have introduced with effect from 1st April, 1989 an insurance cover for Marine Exports on selective basis.

- (c) what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM): (a) No. Sir.

(b) and (c) Do not arise.

## Closure of Delhi Cloth Mills

- 1029. SHRI MURLIDHAR CHAND-RAKANT BHANDARE: Will the Minister of TEXTILES be pleased to state:
- (a) whether the Delhi Administration has permitted the closure of the Delhi

- Cloth Mills, consequent upon the Supreme Court Orders; and
- (b) if so, whether an alternative arrangement is being made to set up a textile mill in the Capital with adequate production capacity, if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SHRI RAFIQUE ALAM). (a) Yes, Sir.

(b) At present there is no such proposal under consideration of the Central Government.

## Terrorist Activities

1030. SHRI MURLIDHAR CHAND-RAKANT BHANDARE; Will the Minister of HOME AFFAIRS be pleased to state:

- (a) what are the details of terrorist activities in the country and the number of persons killed due to such activities during March, 1989; and
- (b) whether any notable change has been observed in regard thereto since the release of Jodhpur detenus?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL PUBLIC GRIEVANCES AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM): (a) to the information furnished by the Government of Punjab, 95 persons were killed in incidents due to terrorist activities in the State during March, 1989. Two bomb explosions took place in Delhi during the month. No person was killed in these explosions. There was no incident terrorist activities in the State of Gujarat and in the Union Territories of Lakshadweep, Daman and Diu and Chandigarh during the month. The information in respect of the remaining States and Union Territories is being collected and will be laid on the Table of the House.

(b) Public perception is more favourable to the measures taken by the secu-
