## Illicit cultivation of poppy

1038. SHRI V.NARAYANASAMY: Will the Minister of FINANCE be pleased

- (a) whether it is a fact that the, Narcotics Control Bureau and the Narcotics Commissioner, Gwalior have destroyed illicit cultivation of poppy in the North Western region of Uttar Pradesh recently;
- (b) what are the other States where cultivation of poppy and ganja has been located and destroyed by the Narcotics Control Bureau so far during the current year; and
- (c) how many persons have been arrested in this connection and what punishment has been awaded to them?

THE MINISTER OF STATE IN THE DEPARTMENT OF REVENUE IN THE MINISTRY OF FINANCE (SHRI AJIT PANJA); (a) Yes, Sir. In a joint operation, the officers of Narcotics Control Bu-Narcotics Commissioner and State Revenue Department destroyed illicit cultivation of poppy, in about 150 acres in Uttar kashi district of Uttar Pradesh in April, 1989.

- (b) Illicit cultivation of ganja in the States of Kerala, Manipur, Mizoram and Tamilnadu and of poppy in Manipur and Mizoram had been located and destroyed by the Narcotics Control Bureau of Collaboration with the State agencies concerned.
- (c) 21 persons in all had been arrested in this connection for appropriate action under the law.
