Application from Coca-Cola Company to establish a unit at Noida Export precessing Zone

1006. SHRI PRAMOD MAHAJAN: Will the Minister of COMMERCE be pleased to refer to the Coca-Cola Company's application for establishing a unit in the Export processing Zone area in NOIDA and state:—

- (a) what are the details of the processing proposed to be done by the Cola Company in the Export Processing Zone area in NOIDA;
- (b) what is the customs tariff nomenclature and the number of items that will be manufactured by the Coca Cola Company in NOIDA; and
- (c) what is the import duty rate on the items to be sold in the domestic tariff area?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI P. R DAS MUNSHI); (a) and (b) company has proposed to produce proprietory compound preparations used in the manuextracts be to for facture of concentrates non-alcoholic beverages. The raw materials consist of emulsion of natural essential oils, flavours and caramel colour. The cost of imported raw material is Rs. 175.18 lakhs and of indigenous raw materials Rs 157.17 lakhs over a five year period. The cost of the processing plant and machinery is about Rs. 163 lakhs. Specific details of the proposed technical operations have not been indicated by the company.

(c) The rate of duty at present on items under Tariff nomenclature 21.06 (2106.90) CTA is 145 per cent (100 per cent basic and 45 per cent Auxilary).
