- (b) whether the investigations led to the issuance of detention orders under the COFEPOSA against one Suresh and one Palikal connected with th_e said two companies;
- (c) whether these orders were actually served on or around 3rd May, 1988;
- (d) whether these orders were revoked •on Or around 10th May, 1988;
- (e) what were the reasons for the revocation of these orders and what was the nature of representation on the basis of which the orders of revocation were made;
- (f) whether the proposal for revocation was supported by the authority which had originally proposed the detention:
- (g) what has happened subsequently to the proceedings arising out of the original acts of smuggling; and
- (h) what was the nature of the smuggling alleged and the extent of evasion of duty?

- (c) to (f) The plant and technology was transferred to M/s. Goodricke

 Group Ltd., Calcutta, at a cost of Rs. 26 lakhs with the pre-condition that all personnel involved in the research would be retained on remuneration not lower than that they were drawing last. AH the eight personnel were re-employed by the new entrepreneur.
