August 1988. Government of West Bengal have sent a composite proposal for a study of metropolitan transport in Calcutta including transways, ferry services, mono rail etc.

- (b) The proposal includes study of assessment of the traffic demand; identification of optimum vehicle population projection of future transport planning needs extension of metro railway, completion of circular railway projects; modernisation of tramway; modernisation and upgradation of the existing ferry services; improvement of infrastructural facilities; comprehensive planning and preparation of feasibility studies for development of ferry services.
- (c) The Ministry of Finance has been requested to identify a suitable donor country to take up the proposed composite study as it *inter-alia*; involves the upgradation of the existing indigenous technologies in this field.

## Modernisation of Employment Exchanges

1279. DR. RATNAKAR PANDEY: Will the Minister of LABOUR be pleased to state:

- (a) whether it is a fact that functioning of the Employment Exchanges have been modernised with a view to providing more efficient services to the job seekers as well as employers; and
  - (b) if so, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR AND THE DEPUTY MINISTER IN THE MINISTRY OF PAR-LIAMENTARY AFFAIRS (SHRI RADHAKISHAN MALAVIYA): (a) and (b) with a view to modernising operations at Employment Exchanges and providing more efficient and objective services to the job-

seekers as well as employers, the Central Government introduced from 1986-87 a Centrally sponsored schemes on computerisation Employment Exchanges. Under the financial assistance on scheme, matching basis was provided to States for computerisation of Employ-Exchanges having a Live Register of one lakh or more registrants (either individually combined group of exchanges) subject to a maximum of Rs. 1 lakh per exchange or 50 percent of the actual cost of computer system, whichever is less.

From 1988-89, the ceiling of Central assistance has been raised to Rs. 2 lakhs per exchange or 50 per cent of the actual cost of the computer system, whichever is less.

During this period (1986—89) Central assistance was provided for computerisation of 38 large Employment Exchanges of group of Employment Exchanges. In addition, some of the State Governments/Union Territory Administrations had taken steps to computerise some of the Employment Exchanges on their own.

The National Informatics Centre (Planning Commission) have developed a common softwere package for computerisation of Employment Exchanges for adoption throughout the country.

## Funds to Voluntary Agencies for Rural Development

1280 SHR PRAMOD MAHA-JAN: Will the Minister of AGRI-CULTURE be pleased to state:

(a) whether the Council for Advancement of Peoples Action and Rural Technology has been releasing funds to various Voluntary Agencies during the last five years;

- (b) what is the yearly release of funds and the number of voluntary agencies funded during each of the last three years;
- (c) the Ministries and Departments dealing with schemes for the same purpose and the funds that are being released by them;
- (d) whether Government propose to centralise all such arrangements under one system with suitable modifications wherever necessary to avoid unnecessary duplication at different levels; and

(e) if not, the reasons therefor?

THE MINISTER OF STATE DEPARTMENT IN THE RURAL DEVELOPMENT IN THE MINISTRY OF AGRICULTURE (SHRI JANARDHAN POOJARI): (a) and (b) The council for Advancement of People's Action and Rural Technology (CAPART) was set up on 1 September, 1986 after the merger of People's Action for Development (India) and Council for Advancement of Rural Technology. The release of funds to Voluntary Agencies during the last 3 years has been as follows:

(c) to (e) The assistance provided by CAPART is for specific projects in rural areas only. Since the objective, philosophy and approach of different agencies working in voluntary sector vastly differ, it may not be possible to bring all of them under a centralised system.
