

Setting up of Coir Industry unit in the Godavari District of Andhra Pradesh

1406. SHRI PRABHAKAR RAO KALVALA: Will the Minister of INDUSTRY be pleased to refer, to the answer to Unstarred Question 1458 given in the Rajya Sabha on the 8th August, 1988 and state:

(a) whether there is any proposal to set up one coir industry unit with Central Government assistance in East or West Godavari district of Andhra Pradesh- and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT IN THE MINISTRY OF INDUSTRY (SHRI M. ARUNACHA. LAM): (a) and (b) The Coir Board has proposed establishment of a Model Demonstration-cum-Production Centre in West Godavari District with the assistance and participation of the Government of Andhra Pradesh. The proposal aims at development of skill in the brown coir sector.

### Setting up of Cochin Thermal Power Station

1408. SHRI THOMAS KUTHIRAVATTOM: Will the Minister of ENERGY be pleased to state;

(a) whether the Government of Kerala have informed Central Government that they failed to get assurance from the Cochin Refinerie, to give natural gas for the proposed Cochin Thermal Power Station;

(b) whether the concerned authority will request the Ministry of Petroleum and Natural Gas to allot gas for Cochine Thermal Power Plant; and

(c) what further action is proposed to be taken to construct this thermal plant?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRI KALPNATH RAI): (a) to (c) Since natural gas is not available at present, in Kerala, it is not considered feasible to supply the same for the proposed power plant. The proposal could be processed further after the various inputs, including the fuel linkage, are tied up and the requisite clearances have been obtained by the State authorities.
