THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) and (b) A letter of intent granted to Pradeshia Industrial Investment Corporation of Uttar Pradesh Limited (PICUP) for setting up of an-aromatic Complex at Salempur in Aligarh District has been treated as lapsed. Some applications for licence for setting up of this Aromatic Complex has been received by the Government. Decision on such applications are taken on Techno Economic consideration. Details of the same are not disclosed until a final decision is taken thereon.
