(b) and (c) Review of no. of sub-divisions based on workload is a continuous process. These are examined as and when the workload justifies.

Uzhavoor telephone exchange

1442. SHRI THOMAS KUTHIRAVAT. TOM: Will the Minister of COMMUNICATIONS be pleased to state:

(a) what is the present capacity of Uzhavoor telephone exchange in Kottayam district, Kerala and how many telephone connections have been provided;

(b) what is the present number of wait listed applicants there;

(c) whether the Department owns land there and if not, by when it is likely to be acquired;

(d) how many applicants are on the waiting list for the Non-OYT Special Category;

(e) what are the hurdles in connecting Uzhavoor exchange with Palai exchange thereby including it in the STD map; and

(f) whether the exchange would be expanded soon?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI GIRIDHAR GOMANGO):

(a) As on 31.3.89 Uzhavoor is MAX-III exchange with 90 line capacity and having 90 working connections.

(b) There are 135 in the waiting list at present.

(c) No, Sir. It is likely to be procured during the Eighth Plan period.

(d) 4 out of 135 are on Non-OYT Special Category.

(e) Uzhavoor is already connected to Palai exchange by group dialling. STD facility is not technically feasible at Uzhavoor being a MAX-III exchange.

(f) Expansion is being planned during the Eighth Plan.
