Departmental promotion to handicapped employees during service

1702. SHRI RAOOF VALIULLAH: Will the PRIME MINISTER be pleased to state:

(a) whether the CCS, rules provide for departmental promotion of a serving Government employee who becomes physically handicapped during his service tenure-

(b) if so, whether a group 'D' employee, having the requisite educational qualifications can be promoted departmentally to senior posts in Group 'D' and 'C' like Library attendant, Zerox Operator, Junior clerk etc.;

(c) if not, whether Government propose to make any provision in CCS, rules for the departmental promotion of such employees and

(d) whether such rules are also likely to be applicable to the organisation, other than Central Government organisations which follow the rules of Central Government in the matter of recruitment?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM): (a) to (d) The departmental promotion of serving Government employees including those who become physically handicapped during their service tenure is regulated by the relevant provisions of the recruitment rules of the higher post. They have to be assessed by

! the Departmental Promotion Committee with reference to the eligibility conditions mentioned in the recruitment rules and their record of service. There is, however, no reservation or special consideration for physically handicapped persons in the matter of promotion.

Recurrence of gastroenteritis epidemic in the Capital

(a) whether Government's attention has been drawn to the press conference addressed by the Resident Doctors Association of Guru Teg Bahadur Hospital, Delhi recently cautioning about the impending recurrence of gastroenteritis epidemic in the Capital and the problems faced by them in handling the situation;

(b) if so, what were the precise observations and suggestions made at the Press Conference; and

(c) what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAPARDE): (a) to (c) No. However facilities at Guru Teg Bahadur Hospital has been adequately strengthened to handle the gastro-enteritis cases. An oral rehydration unit is already working in Out patient Department. ORS and Intravenous fluids are also available. If needed, extra beds will be provided.
