(SHRI K. R. NARAYANAN): (a) Dr. Fleischmanu and Dr. Pons have recently announced results of their experiments relating to cold fusion using palladium as cathode and platinum as anode and lithium chloride in heavy water as electrolyte. Prof. K.S.V. Santhanam of the TIFR has repeated the experiments in a modified electrolytic cell using titanium as cathode and platinum as the anode. Experiments of Prof. Santhanam have prima facie indicated a net energy yield in the Cell. Other scientists in the DAE, in BARC as well as in IGCAR are also working on this subject. In some of the experiments release of neutrons has been obsereved. Experiments carried out so far are of a preliminary nature and more work is being planned.

Written Answers

- (b) and (c) The scope of this research is to produce power by passing an electric current through the cell. If ultimately results show that it is possible to achieve fusion of heavy hydrogen, it could provide a possibility of generation of power. There are however many technical problems to be solved and economic aspects to be considered before power generation can become a reality.
- (d) It is premature to speculate on production of power using this process. However research programmes are being planned.

## Dumping of nuclear waste by U.S. ships

1790. SHRIMATI VEENA VERMA: Will the PRIME MINISTER be pleased to state:

- (a) whether an alert had been sounded in territorial waters along Kerala coast to look out for two U.S. ships which were reported by planning to dump dangerous nuclear toxic waste including hazard materials in Indian ocean; and
- (b) if so, what were the developments and out-come of efforts made if any?

NARAYANAN): (a) and (b) According to the information gathered from the Coast Guard authorities, Cochin, they had received an alart from the Surface Transport Department. So far no such ship has been signed.

## Adulteration of Food stuffs and other consumer articles

1791. SHRI P. N. SUKUL: SHRIMATI SUDHA VIJAY JOSHI:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government's attention has been drawn to a news item which appeared in the 'Hindustan Times' dated the 11th March, 1989 under the caption 'That deceptive shine on red chillies' regarding large scale adulteration of food-stuffs and other consumer articles going on in the country; and
- (b) if so, what action Government propose to take in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAP-ARDE): (a) Yes, Sir.

(b) The States U.T.s have been advised from time to time to keep strict vigil to ensure quality of food-stuffs by drawing more number of samples and to strengthen their Prevension of Food Adulteration enforcement machineries.
