## Shifting of Homeopathy Herbal Research And Collection Centre from Ooty in Tamil Nadu.

SHRI S.S.CHANDRAN (Tamil Nadu): Mr. Chairman, Sir, I am speaking in Tamil.

On behalf of AlADMK, I wish to bring to the notice of the Government an attempt to shift the Homeopathic Herbal Research and Collection Centre from Ooty in Tamil Nadu to some other state. I want the Government to reconsider this decision. Because of the abundant availability of varieties of herbs and the congenial atmosphere at Ooty, this Homeopathy Research Centre was shifted from Uttar Pradesh to Ooty in 1981.

MR. CHAIRMAN: Translation is being provided. ...(Interruptions)... What I mean to say is that he has written out his text in English. ...(Interruptions)...

- SHRI S.S. CHANDRAN: Sir, I want to make my Special Mention in Tamil. ... (Interruptions)... Since the House is not allowing me to make my Special Mention in Tamil, I strongly object to this. ... (Interruptions)...

- SHRI S.S. AHLUWALIA: Sir, notice in English is given for your convenience, because nobody will understand Tamil in your office. That is the reason...(Interruptions)....
- SHRI S. NIRAIKULATHAN; Why are you not allowing him to make a Special Mention in Tamil?...(Interruptions)....
- MR. CHAIRMAN: Now please. do not argue this on ...(Interruptions).... Please sit down...(Interruptions)....
- SHRI S.S. CHANDRAN: I have already informed the Secretary-General...(Interruptions)....
  - MR. CHAIRMAN: Anyway, we will talk it over...(Interruptions)....
- SHRI S. NIRAIKULATHAN: Why don't you arrange for Tamil interpretation?...(Interruptions)....
- MR, CHAIRMAN; We will talk it over...(Interruptions)....We will discuss this issue in the Chamber...(Interruptions)....
- SHRI P.G. NARAYANAN (Tamil Nadu): Okay, Sir ... (Interruptions).... Thank you...(Interruptions)....

- \*SHRI S.S.CHANDRAN: Sir, so far 50 lakh rupees has been spent for setting up this Centre. The AIADMK Government of Tamil Nadu had endeavoured hard in 1987 for getting the land for the Homeopathic Centre. A well was dug up spending Rs. 7 lakh.
- MR. CHAIRMAN: I have told you once to please read out the English text ... (Interruptions)....
- \*SHRI S.S.CHANDRAN: Sir, in 1987 the then AIADMK Government struggled hard.... (interruption)...

- SHRI S. NIRAIKULATHAN: Sir, I have an objection ... (Interruptions)....

- SHRI S. NIRAIKULATHAN: There is interpretation facility ...(Interruptions)....
- MR. CHAIRMAN: I am not objecting to it. The question is, everything should be done systematically. Once you have given notice in English, you read the English text. And, if there is anything, we will see in the translation...(Interruptions)....Would you not like the Members to understand what you are saying?...(Interruptions)....Once when we know what you are saying we will be able to appreciate you...(Interruptions)....
- THE MINISTER OF COMMERCE AND INDUSTRY (SHRI MURASOLI MARAN): Sir, translation is coming in English ...(Interruptions).... English translation is available...(Interruptions)....
- SHRI S. NIRAIKULATHAN: You should arrange for translation ...(Interruptions)....
- SHRI P.G. NARAYANAN: You must arrange for translation ... (Interruptions)....
  - SHRI O. RAJAGOPAL: Anyway, he is half-way through, let him

complete ...(Interruptions)....

SHRI S. NIRAIKULATHAN: Sir, you arrange for English translation ... (Interruptions)....

SHRI C.P. THIRUNAVUKKARASU (Pondicherry): Sir, he may be allowed to speak in Tamil ... (Interruptions)....

SHRI S. NIRAIKULATHAN: Sir, if we do not know English or Hindi, what will you do?...(Interruptions).... Even on currency notes you will find that the denomination printed in Tamil, Malayalam, Hindi, Telugu ...(Interruptions)....

MR. CHAIRMAN: No, no. I am not objecting to that ...(Interruptions).... We will do it ...(Interruptions)....

SHRI O. RAJAGOPAL: Sir, let him complete...(Interruptions)....

DR. C. NARAYANA REDDY (Nominated): Why do you object when he says that he has given notice?...(Interruptions)....You should give due respect to Tamil also...(Interruptions)....There is something wrong with the procedure...(Interruptions).....

SHRI S.S. AHLUWALIA: Sir, Tamil interpreter is available ...(Interruptions)....No, no. The point is, the Secretariat is aware of it. If you want it in English, the English text should be given to the interpreter; he can read it out. There are other Tamil Members in the House who can understand if he is deviating from the text...(Interruptions)....

SHRI O. RAJAGOPAL: Sir, we will discuss this matter in the meeting. Let him proceed...(Interruptions)....

MR. CHAIRMAN: Anyway, you please finish it.

\*SHRI S.S.CHANDRAN: Sir, in 1987 the State Government got this land for the Centre after great difficulties. Even the present AIADMK Government in Tamil Nadu is supporting and assisting all health- related projects. Since sufficient fund has not been allocated for this Centre, this Homeopathy Centre could not function properly. The well has dried up. The herbal plants are withering away. Due to non-allocation of funds, the

Centre could not grow and protect herbal plants. Even the ground could not be levelled resulting in water logging. Herbal plants are drying up. No protection is provided to the herbal plants against the fast flowing winds. regret to say that citing these reasons, the Centre is trying to shift the Centre to some other State. Instead of allocating funds and appointing staff, it is wrong to think of shifting the Centre from Tamil Nadu. One is made to think whether this Centre is being neglected in order to make a ground for shifting it. Sir. this Homeopathy Centre was shifted to Ooty only after thorough study about the suitability of Ooty. Herbal plants necessary for Homeopathy medicines are available in abundance in Ooty as compared to other parts of the country. The atmosphere in Ooty is also congenial to the growth of herbal plants. Therefore, I appeal to the Centre to allocate enough funds for the development of the Homeopathy Herbal Research and Collection Centre at Ooty in Tamil Nadu and abandon the idea of shifting it from Ooty. I thank the Hon, Members and the Hon, Chairman for hearing. my speech in Tamil.

## Need to Join Delhi-Dehradun Marg with North-South corridor
