(a) what is the sanctioned strength of Officers-Designation & Grade-wise in the Commercial Department of Indian Airlines as on January, 1986; January, 1987 ; January, 1988 and January, 1989;

(b) how many Commercial Officers Designation & Grade-wise were/are on the rolls as on January, 1986; 1987 ; 1988; and 1989 against the sanctioned strength mentioned in part (a) above;

(c) whether, in view of ever growing criticism of Indian Airlines customers services and induction of A-320 aircraft in May, 1989, Indian Airlines propose to increase its sanctioned and existing strength of Commercial Officers ; and

(d) if so, what are the details thereof?

(b) what specific steps have been envisaged in the 8th Plan to better the condition of children in India specially the ones below the poverty line ;

(c) what steps Government have taken or proposed to take to tackle the childhood problems, related to nutritional deficiencies like Vitamin-A, Marasmus, Kwashiorkor etc ; and

(d) what steps are proposed to be taken to strengthen the data system which is essential for proper planning?
