

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL) : (a)

Representations have been received against transfer of agro-aviation activities to Vayudoot;

(b) The decision to transfer agro-aviation activities to Vayudoot was taken side after due consideration of option available.

#### Model Railway Station in Goa

1924. SHRI JOHN F. FERNANDES : Will the Minister of RAILWAYS be pleased to be state :

(a) whether in view of International tourist importance of Goa, Government would reconsider to have a Model Railway Station either at Margao or Vasco-de-Gama in Goa; and

(b) if so, by when the work is likely to start on this Model station in Goa ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD) :

(a) and (b) It is not proposed, at present, to add any more stations to the list of 67 Model Stations already approved. However, every effort will be made by the Railway to ensure that adequate amenities, as per norms, are provided at Margao and Vasco-de-Gama railway stations to handle the anticipated traffic, including tourist traffic, at these stations.

#### Working of the Metro in Calcutta

1925. SHRI PUTTAPAGA RADHAKRISHNA : Will the Minister of RAILWAYS be pleased to state :

(a) whether any assessment has been made about the working of the Metro in Calcutta; and

(b) if so, what are the details thereof ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD) : (a) Yes, Sir.

(b) Only part sections of the Calcutta Metro Railway Project, namely, Dum-Dum-Belgachia and Esplanade-Tollyganj have been opened to traffic so far. Metro services on these sections are working satisfactorily and the people of Calcutta have been highly appreciative of the same. Full impact of the working of Metro-Railway will, however, be known only when the rest of the section from Esplanade to Belgachia is completer.

#### Electric locomotive technology in the Railways

1926. SHRI SURESH PA CHOUREI : Will the Minister of RAILWAYS be pleased to state :

(a) whether in a bid to catch up with the latest trends in the electric locomotive technology Indian Railways plans to import 3 phase AC motor drive electric locomotives; and

(b) if so, what is the total number of said locomotives and what would be the total cost of expenditure involved and to what extent those would be helpful in raising the goods trains traffic and passenger trains ?

THE DEPTUY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD) : (a) Yes, Sir.

(b) (i) The total number of locomotives planned to be imported is 40 (30 freight and 10 passenger type).

(ii) The Commercial offers are yet to be opened and hence the costs are not available.
