- (b) The bad strength of the Yatri Niwas commissioned under this scheme at present is 68 beds.
- (c) The likely bed strength in the Yatri Niwases at the end of the Seventh Five Year Plan will be 368.
- (d) The likely percentage of demand to be made by the end of the Seventh Five Year Plan will be 23%.

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT): (a) and (b) The

- · demand for air cargo capacity in the last three years has increased heavily and as outstripped supply, especially during the peak period which extends from January to July. To help exporters, the Central Government has permitted any carrier, scheduled or nonscheduled, to operate any number of flights to take
- cargo out of India, durng this peak period. In addition, the national carrier also operates extra section nights.

Normally, cargo rates are agreed to by all airlines in I.A.T.A. forum and are applicable to all airlines. However, for perishable food articles, mandatory rates have been prescribed by Government which are considerably lower than I.A.T.A. rates.

As regards Shipping Corporation of India, it has adequate space and offer adequate services for serving Indian exports. Shipping Corporation of Indian operates as a Conference line on most of the routes and as a member of the confere-nes charges rates as fixed by the conferences.
