#### **Defects found in the manufacture of Boeing aircraft**

1877. SHRI SHIV PRATAP MISHRA : Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state :

(a) whether Government's attention has been drawn to the defects found in the manufacture of Boeing aircraft in a survey conducted in the the U.S.A. ; and

(b) if so, what is the safety check up carried out by the Government on Boeing planes ?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL) : (a) Yes, Sir.

(b) The Federal Aviation Administration issues air-worthiness directives from time to time for removing defects found in Boeing aircraft. Recently Airworthiness Directives calling for visual inspection as well as high frequency eddy current inspection of B-737 aircraft and Airworthiness Directives requiring inspection of engine fire detection/extinguishing system of all Boeing model aircraft manufactured after 31st December, 1980 were issued which were made mandatory by the Indian DGCA. Indian Airlines and Air-India have complied with these directives so far as their Boeing 737 and 747 Combi-aircraft are concerned.

(c) if so, what are the reasons for which a formal request in this regard has not yet been made under the recently signed MOU with Switzerland ; and

(d) what the steps are proposed to be taken now ?
