to (c) Construction of the new terminal at Bandra (Phase I) is nearing completion. But its commissioning is dependent on provision of a new approach road, which is held up due to some encroachments. Efforts are being made for removal of these encroachments, to enable the work to be completed.

(d) The amount spent so far is Rs. 3.88 crores. The probable date for opening of the Terminal in Nov., 1989, provided the encroachments are removed without much further delay.
