## Supply NCERT books

- 253. SHRI PAWAN KUMAR BAN-SAL; Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether it is a fact that the NCERT books were not supplied to the school students in time during the last year;
- (b) what were the reasons for the inability to supply some books in time this year also when the Delhi Schools re-opened in the first week of April;
- (c) whether the present policy of distribution of text books has been reappraised to check monopoly of a few dealers and to provide self-employment opportunities to unemployed youth; and
- (d) if so, what are the details in this regard?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI P. SHIV SHANKER; (a) There was some delay in supply of some National Council of Educational Research and Training (NCERT) textbooks to the schools last year.

- (b) Delay in publication and supply of some of the new textbooks has been due to delay in preparation and finalisation of manuscripts, non-availability of paper,, particularly coverpaper etc.
- (c) and (d) There is no monopoly of any dealer in the distribution of NCERT text books. Distribution of NCERT text books is handled by the Publication Division of Ministry of Information and Broadcasting through its eight Sales Emporia situated at Bombay, Calcutta, Delhi, Hyderabad,

Lucknow, Madras, Patna and Trivandrum. In addition to this the Council has appointed 13 wholesale agents in the Union Territory of Delhi to facilitate distribution of its textbooks during the year 1989-90. Whole-sale agents have also been appointed in four more cities *viz*. Bangalore, Bhopal, Jammu and Guwahati. It proposes to extend the network of such whole-sale agents to some of the other important cities of the country.

Schools affiliated to the Central Board of Secondary Education (CBSE), including Kendriya Vidyalayas, have been requested to obtain all NCERT textbooks directly from the NCERT, Headquarters at New Delhi

This Company has a joint venture with M/s. Hokke Club of Japan which

operates Centaur Hokke Hotel, Rajgir mainly for catering to Buddhist pilgrim traffic.

The Company has a joint venture with Tea Board for the operation of Mavur Restaurants Sydney at London.
