sea beaches in the country including Orissa; and

(b), if so, what steps have so far been taken in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL): (a) and (b) Development beach tourism in the country is one of the thrust Central Department areas of the Tourism. Under this scheme the Department provides financial assistance to States for development of tourism infrastructure like accommodation, provision of equipment for water-sports, etc. Development of beach resorts is being undertaken in a controlled manner, keeping in view the environmental considerations. Construction of tourist facilities is permitted beyond 500 metres of the tide line except in case of four beaches where construction is permitted between 500 and 200 metres of the high tide line, subject to certain guidelines and safeguards,

The Department has sanctioned projects in Gujarat, Maharashtra, Kerala, Tamil Nadu, Andhra Pradesh and West Bengal and their implementation schedule varies from State to State depending upon the location of the project, it size, executing agency, etc.

As regards Orissa, the State Government have not submitted the revised proposals for financial assistance for development of beach resorts at Chandipur, Paradeep, Gopalpur and Mohododhiniwas, cleared by the Inter-Ministerial Committee.

Expansion of ITDC hotels

Besides, ITDC is presently implementing its on-going scheme of setting up a 31 room hotel (first phase) at Gulmarg, for which a provision of Rs. 140 lakhs is made in ITDC's Annual Plan for 1989-90.

ITDC's Annual Plan 1989-90 does not include any provision for setting up new hotels during the current year.

- (d) and (e) ITDC's overall performance, including performance of existing hotels is monitored on a monthly basis at the highest level, besides periodical performance reviews at various levels. These reviews inter alia, include:—
 - Room Occupancy
 - Turnover
 - Operating net profit
 - Foreign Exchange earnings
 - Progress of expansion renovation etc.. of hotels.

Based on these reviews, necessary directions are given to the ITDC to take corrective measures.
