- (b) if so, what is Government's reaction thereto; and
- (c) wfeat steps Government propose to take for proper maintenance of Indian Museums?

THE MINISTER OF STATE IN THE DEPARTMENT OF CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KRISHNA SAHI): (a) Yes, Sir.

- (b) The views expressed are personal views about museums in India which seem to be highly exaggerated.
- (c) According to the Constitution of India 'Museums" is a State subject However, within the financial cons traints, the Department of Culture, Government of India does the following: «f
- (i) Operates a Scheme of flnaa-cial assistance for reorganisation, development, preservation and conservation of their art treasure to private museums.
 - (ii) The National Museum, New Delhi and Indian Museum, Calcutta run inservice training courses in Museology to which nominees of various museums are admitted similarly.
 - (iii) The National Research Laboratory for Conservation of Cul-

tural Property (NRLCCP), Lucknow train nominees for various departments, museum libraries in conservation and techniques and treat, ment of art objects.

(iv) The Department of Culture has also been advising the State Government, Union Territories from time to time through its Central Advisory Board of Museums the need for taking extra care for the conservation and preservation of their art treasure.

- (c) if so, what action has been taken against the officials who were found responsible for the theft?.

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL): (a) Seven cases of import consignments of computer chips of a "total value of Rs. 20.63 lakhs (CIF) have been reported stolen from the Cargo Terminal at IGIA, Delhi since its inception.

(b) and (c) The cases have been taken up with Police Authorities who have arrested six persons suspected to be involved in the theft. No IAAI official has been named in these cases.;
