Age of superannuation of teaching and non-teaching staff of K.V.S.

(a) what is the age of superannuation of teaching and non-teaching staff of Kendriya Vidyalaya Sangathan;

(b) whether there is any proposal to change it;

(c) if so, what are the details thereof and the reasons therefor; and

(d) the dates from which the changes will come into force in respect of non-teaching and teaching staff?

THE" MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI P. SHIV SHANKER); (a) The age of superannuation of Teaching and Non-Tea* ching staff of Kendriya Vidyalaya Sangathan is 60 years.

(b) and (c) In the Central Government, the age of "retirement for non-teaching staff has been 58 years and that for teaching staff was 60. Based on a review of different ages of retirement for the teaching staff of the schools under different Central Government Departments, Government of India decided in 1988 that in aU these institutions the age of retirement for teachers would be 58 years. However, such of those teachers as enjoy the benefit of retirement at 60 years would get protection for this benefit. In other words, the new stipulation for retirement at 58 years of age shall apply only to future entrants.
