Delhi Police Officers Transferred to Andaman and Nicobar Islands

CHIDAMBARAM): (a) to (c) It is a fact that some officers, after issue of transfer orders by the Ministry of Home Affairs, could not be relieved immediately because of various administrative reasons by the field organisations where they were posted. Out of the Police officers transferred from Delhi Police to Andaman and Nicobar Islands Administration during the last one year, only one DCP and one ACP have not reported to their duties at Andamans so far since these officers have not been relieved by the Delhi Administration.
