It is *not* correct that there is a sharp rise in desertification.

- (b) Does not arise.
- (c) Assessment of the extent of desertification and decline in land under forest cover at the end of 1988 and since the beginning of 1989 has not -been carried out. Desertification is a process which extends over a period of time and its estimation over short periods will not provide interpretable data,
- (d) The National Forest Policy has been revised already in December, 1988.
