- (a) whether it is a fact that type III Government quarters are on subletting in DIZ Area and Baba Kharak Singh Marg depriving genuine Government servants who are in waiting list since 15 years:
- (b) whether it is a fact that Quarter number 1020, 1023, in Block No. 26 and Quarter number 1032 and 1129 in Baba Kharak Singh Marg, are on subletting;
- (c) whether it is a fact that resident(s) of the colony have also complained to this effect;
- (d) what action Government had taken to cancel the allotment of the above quarters; and
- (e) whether it is also a fact that so-called tenants are having telephone connection in Quarter No. 1020 and 1023 of Baba Kharak Singh Marg but not in the name of actual allottees of the quarters?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOP-MENT (SHRI DALBIR SINGH): (a) to (e) Based on the complaints received from the residents of the area especially Baba Kharak Singh Marg, and also otherwise regarding subletting of quarters, spot inspections to detect these cases have been carried out during March to July, 1989. The allotment of all such quarters where subletting has been proved, including Qr. No. 1032 in Block No. 26, B.K.S. Marg, has been cancelled. The allotment of Qr. No. 1023, B.K.S. Marg has been cancelled w.e.f. 5-2-87 consequent upon the allottee's transfer out of Delhi. Action in other cases including Qr. Nos. 1020 and 1129 in Baba Kharak Singh Marg, New Delhi is progressing as per rules.

(b) In his speech at the meeting of the Advisory Council on Public Distribution System held recently the Minister for Food and Civil Supplies, Govt. of Maha. rashtra, made a suggestion to this effect. The allocations of rice, wheat and imported edible oils from the Central Pool for Public Distribution System are made to various States/UTs on a month to month basis, taking into account the overall availability of stocks in the Central Pool market availability, relative needs of the States and other relevant factors. These allotments are meant for the State as a whole and the distribution within the State is the responsibility of the State Government concerned. It is therefore, for the Maharashtra Govt to decide the quantities of these items to be allocated to Bombay.
