THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOP-MENT (SHR1 DALBIR SINGH): (a) to (c) Sonia Vihar is an unauthorised colony having a population of about 10-12 thousand. Since there is no provision of municipal water supply in the unauthorised colonies, people have been using water from their own hand pumps, which is generaly unfit for drinking purposes. However, potable water is being supplied to the residents of this colony through water tankers since 21-6-89. 12 filtered water public hydrants have also been installed.

All the existing hand pumps in Sonia Vihar have been painted in red with a warning "Water is unfit for drinking" and residents are being advised not to use hand pumps for drinking purposes.

As per policy, electricity is provided only in those unauthorised colonies which came up before 1st Jan., 1981 subject to their entitlement being certified by the Town Planner Municipal Corporation of Delhi. There is no proposal to provide roads in this colony.

THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (SHRI JAGDISH TYT-LER): (a) and (b) 414 and 507 applications were received for grant of letters of intent for food processing industries during calendar years 1988 and 1989 (upto 30-6-1989) respectively, 42 and 22 letters of intent were issued during financial years 1988-89 and 1989-90 (upto 30.6.1989) respectively. Regarding capital employed and generation of employment as a result of these letters of intent, information is being collected and, to the extent available will be laid on the Table of the House,
