(b) the details of action taken against each of them so far?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI RAFIQUE ALAM): (a) As per the intimation received from the Customs authorities by the Union Government, gold biscuits were recovered and seized from Hakim M. A. Razzack, Director, CCRUM at the Indira Gandhi International Airport, New Delhi on 10-12-1987.

(b) Hakim M. A. Razzack has been placed under suspension with effect from 12-1-1988.

**Duties of Staff of CGHS**

(a) what are the details of duties of Store-keepers, Pharmacists and Dispensary Clerks as per Chapter-III (Duties of Staff) of Section-I of CGHS Compendium Volume 1, 1982;

(b) whether it is a fact that in various Dispensaries/Units of Indian System of Medicine & Homoeopathy only one Pharmacist is being completed to perform the duties of all the said three posts; and

(c) if so, the reasons therefor; and in what manner Government propose to give justice to such over-burdened pharmacists of C.G.H.S.?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI RAFIQUE ALAM): (a) A statement showing the duties of Store-Keepers, Pharmacists and Dispensary Clerks is enclosed. [See Appendix CLI, Annexure No. 153].

(b) and (c) As per the staffing norm, only one Pharmacist has been posted in Indian System of Medicine and Homoeopathy Units. However, a proposal to augment the staff in Indian System of Medicine and Homoeopathy, Units is under consideration.
