## Draft Report of Japan International Corporation Agency on Development of Calcutta Port

2692 SHRI A. NALLASIVAN: Will the Minister of SURFACE TRANS-PORT be pleased to state:

(a) whether it is a fact that 13-member team from the Japan International Corporation Agency (JICA), entrusted with the task of conducting a comprehensive study of the development of the Calcutta Port and Haldia dock Complex has submitted its draft interim report on the project to the Government of India to improve the Port's draught to 10.4 metres; and

(b) if so, the steps taken by the Government of India in the matter?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT):

(a) The Japan International Cooperation Agency (JICA), which was requested to conduct a comprehensive study on the development of Calcutta Port and Haldia Dock Complex Systems, has subsequently, submitted its draft report to the Government.

(b) The question of any action being taken by the Government of India does not arise till the final report is received.

## Effect of Transfer of Seafarers' Welfare Fund Society from Calcutta to Bombay

2693. SHRI A NALLASIVAN: Will the Minister of SURFACE TRANS-PORT be pleased to state:

- (a) whether it is a fact that due to the sudden shifting of Seafarers' Welfare Fund Society, Calculfa Cells' Office from Calcutta to Bombay on the 8th January, 1981, superannuated seamen, widows and dependents of deceased seamen of Calcutta are facing constant harassment on account of non-payments of their dues despite their correspondence with the Administrative-cum-Accounts Officer, Seafarers' Welfare Fund Society, Bombay; and
- (b) if so, what are the reasons therefor?

THE MINISTER OF STATE OF SURFACE THE MINISTRY (SHRI TRANSPORT RAJESH PILOT): (a) and (b) Calcutta Cell of Seafarers' Welfare Fund Society was wound up in 1985. Calcutta's superannuated seamen and widows of deceased seamen are given all benefits available under the schemes operated by the Seafarers' Welfare Fund Society without any discrimination when they approach the Society. However,
