of In-service courses for teachers Kendriya Vidyalayas

2812. DR. NARREDDY THULASI REDDY: Will the Minister of HU-MAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that large number of teachers of different categories of Kendriya Vidyalayas have not attended any inservice courses

during the preceding six years and eight years;

(b) if so, whether the Sangathan has orgonised or is considering to organise special in-service courses for such teachers:

(d) whether it is also a fact that these teachers are likely to be deprived of senior scales?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI P. SHIV SHANKER) (a) In-service training programmes are organised every year for various categories of teachers i_n Kendriya Vidyalaya Sangathan. These courses have been attended by a large number of the teachers. Information about those who could not attend these courses is not available but efforts are being made to cover every teacher in a period of two years with effect from 15-2-1989.

(b) and (c) Organisation of in-service training courses for teachers is a continuing activity in the Kendriya Vidyalaya Sangathan.

(d) For being eligible for senior scale every teacher is required to participate in an in-service training programme of at least three weeks duration, once in six years. The Kendriya Vidyalaya Teachers who could not meet this requirement have been exempted from this by the Kendriya Vidyalaya Sanga^than for a period of two years with effect from 15-2-1989 within which time, intensified in-service training efforts are expected to have been made.
