- (b) whether Nepal has offered a number of items for export to Pakistan; and
- (c) if so, whether they will be transported through the India Transit point?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) Yes, Sir. As the trade between Nepal and Pakistan is strictly a bilateral issue between these two countries, the question of Government's reaction does not arise.

- (b) Government have seen press reports to this effect.
- (c) Nepal's transit trade with Pakistan would be dealt with in the same manner as its transit trade with other countries.

Contents of Pakistan Premier's letter to Indian Prime Minister

2850 SHRIMATI VEENA VERMA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) what were the contents of Pakistan Premier's letter handed over to Prime Minister Rajiv Gandhi by Pakistan Foreign Minister during his visit to Delhi at the end of July; and
- (b) whether Government have seen Pakistan's Information and Broadcasting Minister's speech in Pakistan Senate that there has been no change in Pakistan's policy on the Kashmir and nuclear issues in the wake of Mr. Gandhi's recent visit to Islamabad; if so, what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) Pakistan's Foreign Minister, during his visit to Delhi at the end of July, did not hand over any letter from the Prime Minister of Pakistan to our Prime Minister.

(b) Yes, Sir Government's views on these issues are well known. Prime Minister Shri Rajiv Gandhi had stated our position at the Joint Press Conference at Islamabad on 17th July.

रेल मंत्रालय के राज्य मंत्री (श्री माधवराव (सन्धिया): (क) रेलपथ के नवीकरण के आंकड़े राज्य-वार नहीं रखे जाते हैं ; तथाषि, मध्य, पश्चिम ग्रीर दक्षिण-पर्व रेलों के सम्बन्ध में सातवीं योजना अवधि केदौरान कुल लक्ष्य 8197 कि मी • निर्धारित किया गया था जिसमें समस्त मध्य प्रदेश आता है । इसमें से सातुवीं योजना के पहले चार वर्षों में यथा 1985-86 से 1988-89 तक किया गया रेल-पथ नवीकरण का कार्य 6717 मि०मी० है।

Transport problem of school children in Delhi

2853. SHRI KAPIL VERMA: Will the Minister of SURFACE TRANS-PORT be pleased to state:

- (a) whether Government are aware of the fact that a number of educational institutions in Delhi have stopped the facility of DTC buses for the transport of students, causing great hardship to them;
- (b) if so, what are the reasons therefor; and
- (c) what steps Government have taken to solve the transport problem of school going children?

MINISTER OF STATE OF OF SURFACE MINISTRY TRANSPORT (SHRI RAJESH LOT); (a) to (c) Consequent upon a judgement of the trial court, the D.T.C. has formulated a new scheme under which D.T.C. would charge school bus fee directly from the students so that there is no profiteering by the schools. Some schools are not agreeable to the new scheme DTC has not withdrawn buses from any of the schools. However, out of 80 schools 14 have stopped availing of such facilities, on their own

DTC is making all possible efforts to provide buses to schools within the frame work of the Court's order. Besides, DTC also provide concessional travel facilities to all students, on their normal services.
