THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (KUMARI SAROJ KHAPARDE); (a) and (b) 100 per cent Export Oriented Units including textile mills are already eligible for dutyfree imports of capital goods. Besides. Government are already permitting import of sophisticated textile and garment machineries at a concessional duty linked to an export obligation of 5 times the value of such imported machineries over a period of 5 years or an export obligation of 75 per cent of the production of machineries.

As the Bye-laws adopted by the bank were not in conformity with Model By-laws, the bank was advised by the Regional Office on 19-6-1989 to amend certain provisions of the By-laws.
