Supply of rice to Tamil Nadu

3306. SHRI TINDIVANAM G. VENKATRAMAN: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

(a) the quantum of rice demanded by Tamil Nadu Government recently for remaining months of 1989 and the quantum of rice sanctioned; and

(b) whether Government propose to increase the supply of rice to Tamil Nadu for the subsequent period; if so, when and details of the increased allotment?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI SUKHAM RAM): (a) No demand for allocation of rice from the central pool for P.D.S. for the remaining months of 1989 beyond August has been received from the Government of Tamil Nadu.

(b) Does not arise.

Accumulation of sewerage water in Sector XII, R.K. Puram

3307. SHRI MOHD. KHALEELUR RAHMAN: Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether Government are aware that a huge pond of sewerage

water has accumulated behind the C.G.H.S. dispensaries in Sector XII, R.K. Puram, New Delhi;

(b) how many complaints have been received from the residents of the Sector and whether any Doctors working in the dispensaries in regard thereto during the last one year; and

(c) what action has been taken by Government in regard thereto and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) There is no accumulation of sewerage water behind the CGHS dispensaries in Sector XII, R.K. Puram, New Delhi.

(b) 10 complaints regarding block age of sewerage were received from the CGHS dispensaries during the last one year. No such complaint was received from the residents.

(c) The complaints received were attended to on priority basis.
