Setting up of Alumina/Aluminium Projects in Visakhapatnam

3138. SHRI YALLA SESI BHU-SHANA RAO:

DR. NARREDDY THULASI REDDY:

Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether it is a fact that the setting up of Alumina/Aluminium Project in Visakhapatnam of Andhra Pradesh has been pending with Government for a long time;
- (b) whether it is also a fact that Government of Andhra Prades h have confirmed the availability of site besides providing the needed infrastructural facilities; and
- (c) if so, the reasons for delay in setting up this project till to-date?

THE MINISTER OF STATE IN THE DEPARTMENT OF MINES IN THE MINISTRY OF STEEL AND MINES (SHRI MAHABIR PRASAD): (a) A Feas bility Report for setting up an Alumina Complex in Visakhapatnam District of Andhra Pradesh was initially prepared by Soviet experts in 1980. Subsequently a revised Feasibility Report was prepared in 1987 for setting up an export oriented Bauxite, Mining complex.

(b) The Government of Andhra Pradesh have confirmed the availability of infrastructural facilities for the project like land, water and power.
