# Independent security agency at airports to monitor ground handling operations

(a) whether to check up airport security, the Ministry of Home Affairs has suggested creation of an independent security agency to monitor ground handling operations at major airports, various sensitive functions including check-in, passenger facilitation, cleaning of aircraft, loading, unloading and pushback facility;

(b) if so, whether the specialized agency will include the experts from various organisations like the Directorate General of Civil Aviation, Bureau of Civil Aviation Security, Central Industrial Security Force and Airports Authority of India;

(c) if so, whether Ministry has considered the suggestions; and

(d) if so, by when a final decision will be taken?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI PRAFUL PATEL): (a) to (d) A Statement is laid on the Table of the House.

SHRIMATI PREMA CARIAPPA: Sir, the hon. Minister has replied to may question. But if he agrees, I would like to ask another very specific question which does not pertain to this.

Sir, the Indian airlines is known for delay. Two days back, when I was coming from Bangalore, I boarded the 4:30 flight in the evening. It actually started at six. But, on the way, hey found some technical snag and it landed at Hyderabad. From there, we had to take another flight and reach Delhi after midnight. I would like to know from the hon. Minister whether any security check-ups or technical check-ups are taken up before a flight takes off from the airport.

SHRI PRAFUL PATEL: Sir, I just take the question in the right spirit, for everybody in concerned about safety and security and, therefore, I am attempting to answer. Otherwise, it doesn't arise our of the original question. But, I am sure, all of us fly and we are all concerned about safety and security. I can assure you that in terms of safety, for every aircraft which flies the Indian skies, be it of Indian Airlines or any other carrier, there are

strict safety measures which are adopted by the Directorate General of Civil Aviation. We comply with all the international norms. In fact, very recently, the International Civil Avaiation Organization, which is the world body that conducts annual audits for many member States, conducted random audit for the DGCA and the entire Indian aviation sector, including airlines, let me assure the House that ICAO Audit Certification for India has been the highest that they have anywhere in the world. I think it is a compliment to the Indian civil aviation sector which is now on a very high growth trajectory. Of course, there are concerns; I share the concern of the hon. Member. Technical snag can occur in any aircraft and the Indian Airlines just happens to be one of those airlines which has, over a period of time, got a much aging fleet.

It has its own concerns. Any ageing fleet would have definitely some more technical issues. But, that does not mean, the age of an aircraft does not mean, it is safe or unsafe. All aircraft, as along as they are airworthy are equivalent in terms of safety. This may be one of those incidents which have taken place. I assure you that the Indian airlines is also doing its very best. They have shortage of aircraft. As all of us know, we have not been buying aircraft for may years. But, now the Government, after many, many years has taken this decision to induct new aircraft. I am sure, with the induction of new aircraft, the performance of the Indian Airlines will improve. But, once again, Sir, because it is a very general question, I can assure the entire House, through you, Sir, that there is absolutely no compromise on safety or security of any aircraft flying in India...(Interruptions)...

SHRI SITARAM YECHURY: I return to the original question and the original answer, Sir, if you permit me. Sir, I want to draw the attention of the hon. Minister to one fact that *in* this House we had earlier discussed the news that appeared that one of the private operators who was given the task of modernising the Delhi airport had appointe a foreign, Greek national as in-charge of their security operations. Then, the House expressed its concerns, I remember, Sir, saying that how you can have foreigners in-charge of security operations at the Indian airports. And, in the process of privatisation, have we actually diluted or compromised our security concerns, to this extent? The House was assured that this matter will be looked into, and then the remedial measures will be taken.

Now, what has the Government done about this? Do we still have a foreign national continuing to head the security operations at the Delhi Airport?

SHRI PRAFUL PATEL: Let me, Sir, first correct my very esteemed friend, Shri Sitaram Yechury, that that Government has not privatised the Mumbai and Delhi airports. We have only adopted a joint-venture.....

SHRI PRAFUL PATEL: No, no; it is not even privatisation. It is a joint-venture for a limited number of years. It is not privatisation. But, anyway, coming to your concern about safety and security and a foreign national being associated, I think, this is a very larger issue which needs to be looked at in the right perspective. However, each and every person, whether he works in an airport on in an aircraft or has anything to do with aviation, has to first be cleared by the Bureau of Civil Aviation Security which, in turn, does the check through the Home Ministry-various agencies are involved in it. And, after the due clearance has been received, then only a person is allowed to be associated either with a project or with an aircraft. Mr. Yechury, I would just like to expand on this a little bit by saying that, today, there are several foreign pilots who fly the domestic carriers of the country. It is arising out of the shortage of pilots because the aviation sector has grown faster than the number of pilots which our country was producing so far. Does that mean that those pilots who fly these aircraft, after due security check, are any threat? There are foreign airlines which also come and operate in India, and they are also operating on Indian sky

.....{*Interruptions*)......So, I would like to assure the hon. Member that there is no compromise on this issue. No person has been appointed or is permitted to work unless he is thoroughly screened and checked and clearance is obtained from the Ministry of Home ......(*Interruptions*)......

SHRI SITARAM YECHURY: Sir, I am very grateful to the hon. Minister

for this, but there is one thing......(*Interruptions*).......Sir, the point is very simple. Taking professional help and assistance or employing professionals who are foreigners is one matter. But, handing over the security of the airport to a foreign national, to head the entire security operations is an entirely different matter. So, don't confuse it by referring to having foreign national pilots.

SHRI PRAFUL PATEL: Sir, I do not want to enter into a dialogue with the hon. Member, but I can assure him that the security function of an airport, or, any airport, for that matter, in India, remains a sovereign function. It is the Airports Authority, through the CISF, which is entirely responsible for the security not only of the Delhi Airport but all the Airports of India. And, the ATC also, is again a sovereign function which remains with the Airports Authority ...(*Interruptions*)... So, as far as safety in the air and safety on the ground, is concerned, this is not entrusted to any foreign national. ...(*Interruptions*)...

MR. CHAIRMAN: Shri Mukhtar Abbas Naqvi. ...(Interruptions)...

SHRI TAPAN KUMAR SEN: Sir, It is a matter of concern that a Greek national has been made in-charge of security operations.... (*Interruptions*)... You assure the House that ...(*Interruptions*)...

SHRI PRAFUL PATEL: I have assured the House, and I assure the House again that the security of Indian airports, including the Delhi airport, which is in joint-venture, remains with the CISF. The air security is with the ATC which remains with the Airports Authority. So, there is no question of safety and security as an issue.
