Objection raised by ECL for setting up a new satellite township in Burdwan, West Bengal

594. SHRI CHITTA BASU: Will the Minister of ENERGY be pleased to state:

- (a) whether the Eastern Coalfields Limited have since raised objections for setting up a new satellite township at Mangalpur, in Burdwan, District Raniganj, West Bengal;
- (b) if so, what are the reasons therefor:
- (c) whether it is a fact that West has since Government decided to go ahead with the plan; and ·
- (d) if so, what is the Central Government's reaction thereto?

THE MINISTER OF STATE DEPARTMENT IN THE COAL IN THE MINISTRY OF ENERGY (SHRI C.K. JAFFAR SHARIEF): (a) and (b) The land in Mangalpur, where the Govern-ment of West Bengal proposes to set up a new satellite township, contains huge reserves of high quality coal to the extent of 71 mllion tonnes. In case, township is allowed to be set up on this land, valuable coal would be locked up to the detriment of the economy of the State and the Country. Limited has Eastern Coalfields therefore, pleaded for setting up of township on some other alternative land.

(c) and (d) The Central Government is not aware whether the West Bengal Govt. has taken any final decision to go ahead with the plan. This matter was discussed in a meeting taken by the Minister for land & Land Re-venue, Govt. of West Bengal, on 19.7-89, in which Chairman-cum-Managing Director, ECL objected to the setting up of the proposed satellite township; but it appear

that the West Bengal Govt. has not given up its plan to go ahead with the setting up of the aforesaid township.

The plan after approval will be implemented in stages according to the availability of funds.

- (c) whether an alleged non-descript company called RSW of Canada, which reportedly has no back-up technical supporting assistace, has been included in the shortlist of Consultants in preference to several other much more experienced Canadian, British and U.S. consulting organisations in this field;
- (d) whether NHPC has made any inquiries from international customers on RSW's past performance in high-voltage transmission projects; and
- (e) if so, what are the names of the international customers so contacted?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRI KALPNATH RAI): (a) No World Bank aid has been received by NHPC so far. However, the proposed 800 KV transmission system from Kishenpur (J&K) to Moga (Punjab) has been appraised by the World Bank for funding.

- (b) and (c) The corporation has shortlisted six International Companies incuding M/s RSW of Canada for designing the transmission system in consultation with Central Electricity Authority and the World Bank.
 - (d) and (e) No, Sir.
