THE MINISTER OF STATE OF

of 91 wells drilled and tested in
Onland and Off shore areas of Cau-
very basin upto 1st July 1989, 20
wells onland and four off shore pro-
ved to be oil bearing.

(b) and (c) Oil is being produced
from Narimanam and Bbuvanigiri
structures only through Early Pro-
duction System at a total average
daily rate of about 236 tonnes and
sent to Madras Refineries Ltd (MRL)
by tankers.

(d) MRL have submitted a pro-
posal to the Government for setting
up facilities for distillation of 5,0 ,000
Tonnes Per Annum of Crude oil
and separation of 16,5000 metre
Tonne/year of LPG in Cauvery
basin. Action for processing of the
proposal has been initiated.
