

**Construction of Bhatni-Varanasi
Broad Gauge Rail Line**

931. SHRI ISH DUTT YADAV:

(a) when the construction of Bhatni-Varanasi broad gauge rail line started;

(a) In April, 1980.

(b) Section from Bhatni to Mau is expected to be opened as Broad Gauge by March 1990 and balance by March 1991, subject to availability of resources in 1990-91.

(c) Estimated cost is Rs. 80.8 crores. The expenditure upto June, 1989 is Rs. 39.59 crores, approximately.

**Rehabilitation of persons affected by
Nhava Sheva -Port Project**
