-different cutting centres in the world. There is no evidence to suggest that the increase was discriminatory against the Indian Diamond Cutting Industry and is likely to adversely affect Indian Industry, Both imports of rough diamonds and exports of cut and polished diamonds from India have registered increases during April-June, 1989 as compared to corresponding figures for the previous year.
