Information of Bihar in respect and Madhya Pradesh is being collected. No specific instande of profit making by the State Governments in the supply of specially subsidised rice in ITDP areas has come to the notice of th<sub>a</sub> Government. However, from December, 1985 to August, 1988 Andhra Pradesh supplying common rice under this scheme at Rs. 2.00 per kg. against end retail price of Rs. 1.85 per kg. fixed by the Government.
