SHRI KANHU CHARAN LENKA (Orissa): Sir, I extend my grateful thanks for your kind greetings. I also thank all  $m_{\nu}$  colleagues for their greetings, the senior colleagues for their blessings.

## Problems Arising out *ot* Reduction in Offtake of Iron Ore by MMTC for the purpose of Export

SHRI KANHU CHARAN LENKA (Orissa): Mr. Vice-Chairman, I want to bring to the notice of the Government the serious problems arising out of the reduction in the offtake of iron ore by MMTC for the purpose of export.

MMTC have decided to reduce procurement of iron ore from the non-captive mines for the purpose of export by 50 per cent during 1988-89. The mines are located in the tribal districts of Keonjhar, Mayurbhanj and Sundar-garh. As a result of the decision of the MMTC effecting reduction in procurement by 50 per cent of. the quantity procured during 1987-88, a number of minr-s have been forced to close down and there has been reduction in the strength of mine workers. This has also affected the revenue of the State and business of Paradin Port. The reasons, advanced by MMTC are that they have exoort contract for only 12 lakh tonnes from Parad'o Port during 1988-89 and they are carrying sufficient

stock of iron ore at the port and at the various railheads in Barjamda-Bans-pani Sector. Besides, MMTC are incurring losses on export of iron ore through Paradip port mainly because Of the high incidence of railway freight. Sir, the closure of the iron ore mines and consequent retrenchment of a large number of Tribal Workers will spell economic disaster in the Sensitive Tribal areas of Bihar and Orissa.

Sir, a directive should be issued by the Ministry of Commerce to the MMTC to increase their procurement to at least last year's level. Secondly, with a view to reducing the continuing losses of MMTC on export of iron ore through Paradip Port, the Railway Ministry should be persuaded to give a concessional freight, and simultaneously steps should be taken to augment the ore handling capacity in Paradip Port so that as an interim measuree the Port can handle ore carriers of at least one lakh DWT capacity. Thank you, Sir.

SHRI BASUDEB MOHAPATRA (Orissa). Sir, T would like to associate myself with the views expressed by Shri Lenka.

SHRI SUBAS MOHANTY (Orissa): Sir. this is a very serious problem. I want  $t_0$  associate myself with the want to urge upon the Government of India to direct the MMTC to secure additional market facility for export of iron ore from Paradip Port and increase their procurement from those mine areas. And another major factor which Mr. Lenka has also mentioned is that, the Railwav Ministry should uive a concessional freight so that it does not incur more losses by exnortinff through Paradip Port. Thank  $v_0$ u, Sir.

Sir, lately there have been a number of incidents of attacks on the press in various parts of tbe country, particularly in States ruled by the Congress. And, in fact an<sub>v</sub> attack o<sub>n</sub> the pressmen is au attack on democracy itself. And the police are inactive and anti-social elements are being used by some political elements t<sub>0</sub> launch attacks on the press. And recently such incidents have increased in States like Uttar Praoiefb and Himachal Pradesh. There have been brutal attack<sub>s 0</sub>n Shri Hari Orr Gupta, a reporter of 'Viswa Manav' daily at Bareilly. And there were attacks on Shri Subhash Gupta of Daily Amar Ujala' and there was a day-light murder also of Mr. Umesh Dobal in Garhwal. These are some of the recent incidents of attacks on the journalists. Andthe delegation me( the Home Minister and requested that fiction should be taken immediately to protect the journalists and the press. Instructions should be issued tj the State Governments also to make soeciai efforts for

the protection of journalists. And through you, Sir, I would like to draw the attention of the Government to this serious problem. I hope the Union Government would take up matter with the concerned State the Governments so that such incidents will not recur. Thank you. Sir.
