There is the Valley of Flowers which comprises so many varieties which are not available in the world and this also attracts tourists from inside th_P country as well as outside. So, there i_R a very heavy traffic on the roads leading to Rishikesh. Badrinath. the ValW of Flowers, Hemkund and Kedarnath. Every year, hundreds and hundreds of peonle die Ijecause of the he aw traffic and because of the accidents to vehicle,, on these roads. Th» U.P. Government is incanable n* taking ur> the issue of a pilerim highway because of financial constraints. So T would request you io apprise the Central Government

about this problem so that it can take up the issue of developing a national highway connecting these pilgrim and tourist centres.
