THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ PARDE): (a) and (b) There are about 40 locally manufactured Cobalt Units installed in various radio-therapy departments in the country. At the time these units were manufactured they have been tried and tested by Bhabha Atomic Research Centre (BARC) authorities before installation.

After a long use, it was found that they had some limitations in functioning, marginally effecting the treatment only in some patients. Most of these machines are likely to be condemned during the next five years.
