- (a) whether Government propose to sponsor Pakistan's case for rejoining the Commonwealth; if so, what are the reasons therefor:
- (b) whether the issue was discussed with the Pak Prime Minister Mrs. Bhutto at Islamabad recently; if so, whether she had made any request in this regard; and
- (c) whether Government propose to oppose Fiji's request for re-admission into Commonwealth; and what are the names of the countries which are supporting Fiji and those which are opposing?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) Government of India have agreed to

welcome and support Pakistan's case for rejoining the Commonwealth whenever Pakistan makes a formal request to the Commonwealth, it will be recalled that a democratically elected Government of Pakistan had pulled out of the Commonwealth. If another democratically elected Government of that country wishes to rejoin the Commonwealth, India would support it.

- (b) No, Sir.
- (c) The Government remain opposed to Fiji's readmission into the Commonwealth. Since Fiji has not made any application for readmission to the Commonwealth, the policy of other countries in this regard is not known,
