Abid Hussain Panel Report on Capital Market

1016. SHRI SURESH KALMADI: Will the Minister of FINANCE be pleased to state;

(a) what is Government's observation on the reforms of the capital market as suggested by the Abid Hussain Panel;

(b) what are the details in this regard; and

(c) what steps are being proposed to be taken to augment investment in the stock market?

THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC AFFAIRS IN THE MINISTRY OF FINANCE (SHRI EDUARDO FALE-IRO): (a) and (b) Details regarding the recommendations cannot be disclosed until a decision is taken by Government on the Anal Report submitted to Government.

(c) Taking measures for augmenting investments in the stock market is a continuous process. The Budget for 1989-90 also contains proposals for the development of the capital market. These include extension of facility of no tax deduction at source on interest payments on Bonds and Debentures upto Rs. 2500 as in the case of dividends, and introduction of an Equity Linked Savings Scheme, which will be operated through UTI and recognised Mutual Funds.

Export policy of cotton

1087. SHRI SHIV PRATAP MIS HRA: Will the Minister of TEXTILES be pleased to state:

(a) whether Government propose to formulate a staple cotton export policy; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SHRI RAFIQUE ALAM): (a) and (b) Government had announced a long-term export policy (valid till the current cotton year, 1988-89) on cotton. While under the policy six-lakh bales of cotton were to be exported every year, the exports could not stabilize due to wide fluctuations in domestic availability and prices.
