Virus Damaging the Memory of Computer

2192. DR. YELAMANCHILI SIVAJI; Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that a virus is damaging the memory and other components of computer system through out the country in general and at Visakapatnam in particular; and
