- (b) and (c) The Planning Commission has imposed a ceiling of 8% on the growth of Indian Airlines' capacity during the Seventh Plan period. Attempts are being made to relax the ceiling. Apart from the ceiling, Indian Airlines suffered from capacity shortage due to a number of accidents and also late arrival of leased aircarft, than planned.
- (d) Indian Airlines has inducted a number of aircraft on lease and from April. 1989 onwards, the 19 Airbus A 320 aircraft will be inducted into its fleet in a phased mariner.

THE DEPUTY MINISTER IN- THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD): (a) Hyderabad, Vijayawada, Tirupati and Waltair railway stations in Andhra Pradesh have beeh selected to be developed as Model Stations. Work at all the stations except at Hyderabad has commenced.

(b) to (d) The work at Hyderabad station is proposed to be taken up in phases. In phase-I, works costing Rs. 1.50 crores have been proposed and will be started in 1989-90.

- (c) The follwing steps have been taken in order to improve punctuality:—
 - (i) Overall utilisation of Boeing aircraft has been reduced so as to provide standby capacity at base stations.
 - (ii) Additional aircrafts have been leased from various sources.
 - (iii) Punctuality of flights has been constantly monitored at various levels.
